**I. DECEMBER MINUTES**

Minutes were approved as written.

**II. TREASURER'S REPORT**

Report provided by Pete Wendler. As of December 31 the league has a balance of \$74,108.09 in its combined accounts. This does not include a sponsorship check from Chapman automotive Group and \$1,000 to \$2,000 in undeposited cash and checks.

With a year-end balance in excess of \$50,000, the league may have to file taxes differently. Pete to investigate.

**III. OLD BUSINESS**

**A. Fields**

We have received field assignments through February. Field assignments for the remainder of the season should be received by the next meeting.

Current projections, barring weather cancelations, indicate that the Premiere Division will play 18 regular season matches. All other Divisions will play between 16 and 18 matches.

**B. Division Balance**

A Division 1 team, Magma Central has dropped out of the league, balancing the number of D1 teams so the new team being discussed will not be added.

**C. Chapman Sponsorship**

Pete picked up the sponsorship check from Chapman Automotive Group. This money goes, primarily toward team uniforms and branded league and tournament awards.

**D. Field Setup**

Steve reported earlier that the CoT is looking into filling in the overly-wide trenches that act as lines at the Udall fields. He asked about the possibility of painting lines at that park but because of the winter conditions (no winter grass) there is too much dirt to make paint effective.

**IV. NEW BUSINESS**

A. Website Advertising

All advertisements for companies who have not paid the 2017 yearly fee will be removed from the website until payment is received.
